There were no questions, concerns or objections with the proposed budget for 2022. The Budget Hearing concluded at 4:18. M. Agenda Item #5: Pat Morrow – MSA – Updates on Facility Plan: P. Morrow gave everyone a hand-out of the MSA Wastewater Facility Plan updates. He went into depth explaining each area of the plant that the facility plan covers. There was discussion about the different equipment, inspections and options that will be covered for each area. After the holidays P. Morrow will be contacting W. Peters to set up time to go over the all the equipment/ upgrade options.
