The meeting was called to order by President T. Wipperfurth on May 11, 2021 at 4:00 P.M. All public notices have been posted to meet with the open meeting law and the building is accessible for the handicapped.

Approval of Agenda 5-11-21: M. Killian made a motion to approve 5-11-21 agenda. R. LaPlante seconded the motion. All in favor, motion carried.

Approval of Minutes 4-27-21 Meeting: R. LaPlante made a motion to approve the minutes for the 4-27-21 meeting; M. Killian seconded the motion. All in favor, motion carried.

Agenda Item #4: Bobby Nowak of Spectrum Insurance – Present Business Insurance Proposal: Bobby Nowak of Spectrum Insurance presented the board of commissioners the business insurance policy proposal. The carrier he presented for coverage was Continental Western Group. He handed out information about Spectrum Insurance and what they offer as free services if you choose them as the insurance broker. He then went into great detail explaining the coverages for the property, buildings, vehicles and other coverages outlined in his proposal. He highlighted the coverages that are offered by Continental Western that are not offered from other insurance carriers. He explained the blanket coverages and Workers Compensation coverages as well. The board thanked him for coming in to present the proposal.

Agenda Item #5: Review of ib Insurance – Business Insurance Renewal Proposal: The Lakeland Sanitary District's current insurance broker, Jesse Kimball of ib Insurance had dropped off the renewal business insurance proposal for the board to review. He was able to quote with The Cincinnati Group now that ib Insurance was acquired by Compass Insurance Companies. This insurance carrier was not available before to receive quotes/coverages from. The board went over the proposal and compared it to last year's coverage with Selective Insurance. The annual quote came in lower and is offered as a three-year policy with a rate lock. There was a discussion about both proposals presented. The board advised W. Peters to call B. Nowak of Spectrum Insurance tomorrow to ask if he can offer a three-year rate lock for the policy like The Cincinnati Group offered. They also advised W. Peters to call J. Kimball of ib Insurance to see what they offer for free services in comparison to Spectrum Insurance.
